

Community Restitution Work (CRW)

- Community restitution work must be done for a **state registered non-profit or public agency** within Poulsbo city limits.
- You must submit a separate form for each agency you completed work for.
- Community restitution work must be supervised and cannot be supervised by, or work done for, a family member.
- Fines are credited at the current federal minimum wage rate for every satisfactorily completed hour of CRW.
- If the Judge did not designate how many hours per month you are to complete contact the court office at (360)779-9846 for the number of hours to be completed monthly. Fax, mail, or drop off at the court office a copy of your progress each month.
- **If the agency is not listed on the Pre-Approved List below, your community restitution hours may not be started and will not be accepted until you receive written authorization from the Judge.** If you are unable to complete your community restitution hours with an agency listed on this sheet you must submit a letter to the Judge containing:
 1. Statement why you are unable to complete your hours from the Pre-Approved List.
 2. Agency name and address of where you want to complete your community restitution hours.
 3. The authorized community restitution supervisor's name and phone number for the agency you are requesting.
 4. Exactly what you will be doing for them.
 5. Verification from the agency that they are a state registered non-profit agency.
